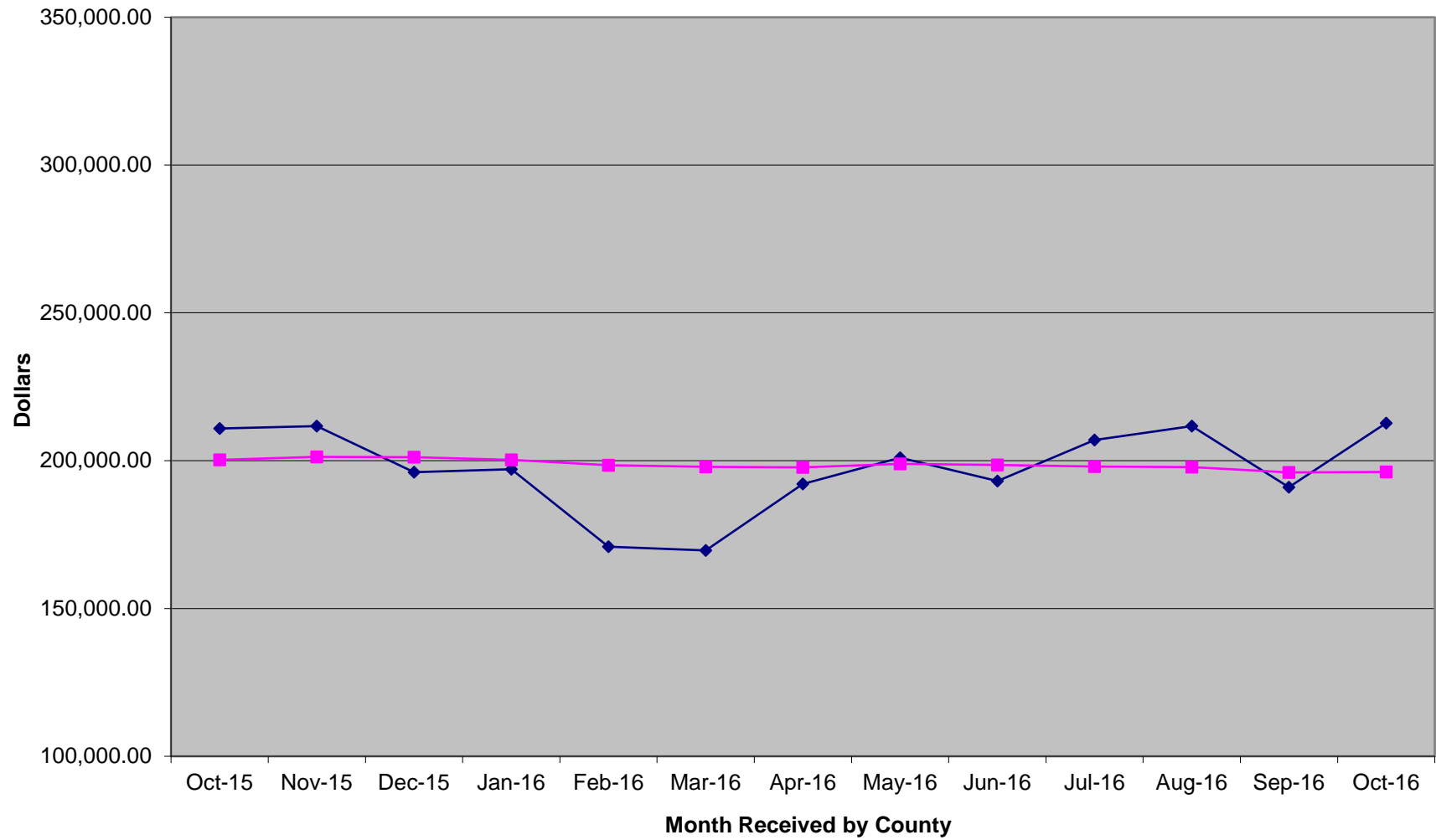

Month Received by County 12 Month Average

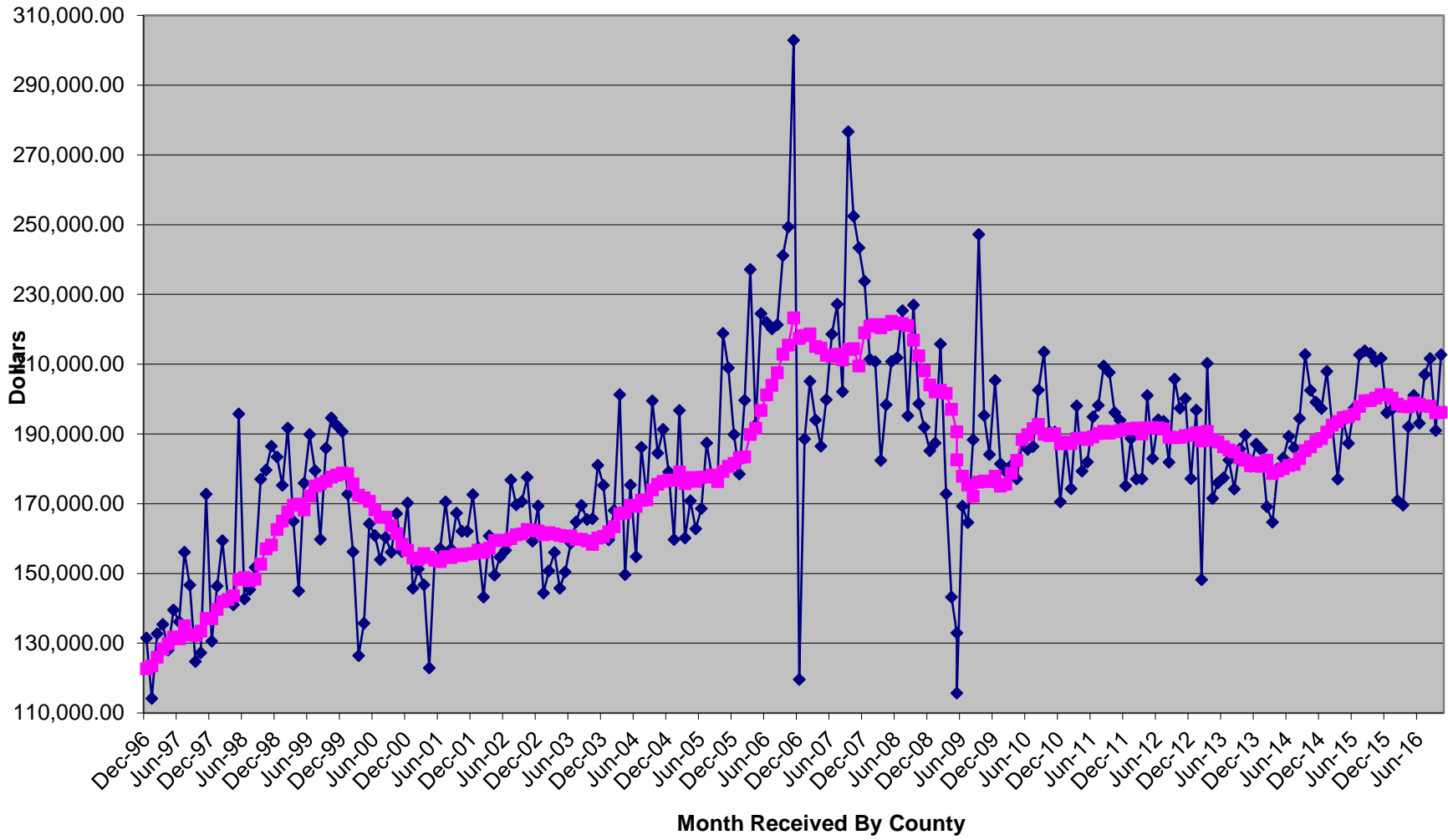
